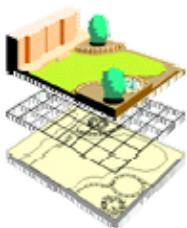

Under Construction... Former Industrial to Retail Conversion

A deteriorated and vacant former industrial building in West Hartford is being removed, the site cleaned up, and a new retail development, anchored by a new Stop & Shop constructed. The project site also includes the existing Crazy Bruce store which will be removed as part of the work and relocated to new space in the main plaza building.

The project received Town and State approvals this past summer and demolition of the existing building and site preparation is well underway with a spring 2010 start planned for the new buildings. Meehan & Goodin has and continues to provide the land surveys, site engineering, permit assistance, and construction administration services for this interesting project.

Approved... Sewer Pump Station Improvements



As part of our "on-call" services for the Eighth Utilities District in Manchester, we designed site improvements and permit applications as part of a sanitary sewer pump station upgrade. The existing standby electric generator (inside the building) will be removed, relocated and reused for a non-critical application at another District building as part of the project.
